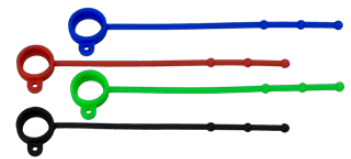

Small shifting of imprint cannot be avoided when printing. As each product is manufactured and printed individually, up to 3/16" movement in logo alignment may occur. 100% full coverage is not possible, small pin holes and gaps in the imprint might be seen when magnified. Hand Sanitizers are intended for individual use and cannot be compared one to another. Small bubbles in vinyl label cannot be avoided as labels are applied manually and cannot be perfectly aligned on bottle or compared one to another or order to order.
