This 3-ply protective 95% cotton reusable facemask has an integrated metal nose bridge wire to create a snugger fit over your nose. It also features silicone ear loop size adjusters for adjusting to proper fit while easing stress on ears. One size truly fits all! Price includes a one color, one position imprint, on side of mask (white imprint recommended, but black also available on red and royal blue mask colors).

**Mask Size:** 7-1/2" W x 5-1/4" H

**Overall Size with ear loops:** 15" W (adjustable down to 9" W) x 5-1/4" H

**Imprint Area:** 1-3/4" x 1-3/4" on left or right side of mask.

**Material:** 3-Layer 95% Cotton and 5% Spandex with 85% Nylon and 15% Spandex Loops and Silicone Size Adjuster. 420 GSM thickness. Thread Count: 40S.

**Colors:** Black, Royal Blue, Navy Blue and Red.



**Setup Charge:** 55.00 (G). **Price Includes:** one color imprint on left side of mask (one color only). White or Silver imprint recommended on black and navy mask colors and black or white imprint on red and blue mask colors. Setup Charge: 55.00 (G). **2nd Location Imprint:** add .35 (G). Add another 55.00 (G) setup charge for a different logo in 2nd location.

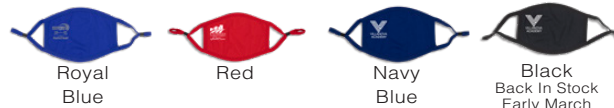

Dye-sublimation printers use CMYK (Cyan Magenta Yellow Overcoating) colors, which differs from the more recognized CMYK colors in that the black is eliminated in favor of a clear overcoating.
