Packaging: Bulk. Nail files ship bulk and are not inserted into Clear Vinyl Sleeves. For insertion please add .20 (G) and specify. **Material:** Double sided grit layered over EVA Foam. **Weight:** #5400 1-1/2lbs. (100 pcs.) - #5402 1 lb. (100 pcs.)
